BURLINGTON BOARD OF FINANCE REGULAR MEETING Wednesday November 17, 2021

The regular meeting of the Burlington Board of Finance was held on Wednesday, November 17, 2021. Board members present were: Gerald Mullen, Chairman, Steve Carrier, Sue Brault, Andrew Klimkoski, Skip Achilli and Mark Klepacki via telephone. Also in attendance were First Selectman Ted Shafer, Finance Director Elisa Michell and First Selectman Elect Douglas Thompson.

Call Meeting to Order

Chairman Mullen called the meeting to order at 6:31PM.

Acceptance of Minutes from October 28, 2021 Special Meeting

Received 65% of 2022-2023 budgets from Department Heads thus far.
