#### Financial Report -

Mrs. Michell reviewed and discussed key year-to-date financial reports for November 30, 2021 revenue and expenses. Expenses were at 39%. Revenue is at 53 % of budget.

She provided the following finance updates:

Audit Update:

Audit extension was filed with the State for January 31, 2021.

Auditors are continuing with their review and forwarding questions for response.

Budget requests from departments have been received. Gathering additional details for review with First Selectman. Working on uploading the information into Edmunds.

Received preliminary draft audit for review. CLA to present to Board end of year or beginning of January as special meeting.

October & November 2021 reserve transfers discussed.

Bank/investment/reserve account balance reports prepared by Treasurer Savino were reviewed and discussed. Following discussion, on a motion made and seconded by Brault/Kirschner, it was unanimously VOTED TO:

#### **Tax Collector's Report**

The Board reviewed and discussed the Tax Collector's Report for month ending November 2021. Reports covered information on collection, and uncollected, property taxes and sewer fees/assessment. Following discussion, on a motion made and seconded by Brault/Achilli, it was unanimously VOTED TO:

## First Selectman's Report

Thompson reported that the BOS recommended to the Board of Finance an appropriation of funds from EDC budget up to \$384.00 to cover annual fee of Survey Monkey for Library Lane Advisory Commission use.

**Motion** made, seconded and passed unanimously to authorize \$384.00 for annual Survey Monkey fee. (Achilli/Kirschner)

BOS discussed the Covey Road Bridge contract. Scott Tharau was present and provided an update to the BOF.

The BOS authorized Thompson to approve the Cardinal Engineering proposal for construction inspection services for Covey Road bridge replacement project once all permits are in place to proceed, not to exceed \$93,000, half of this amount will be covered by grants approved.

The BOS also authorized Thompson to approve the Black & Warner proposal for construction of the Covey Road bridge replacement project when all permits are in place to proceed, not to exceed \$620, 710.50, half of this amount will be covered by grants approved.
