Also in attendance were Finance Director Eleanor Parente, First Selectman Theodore Shafer and Tax Collector Allison Tharau.


Approve the October 18, 2017 minutes as presented.

## Tax Collector's Report

Mrs. Tharau reviewed and discussed the October and November, 2017, Tax Collector's Reports. Key reports included fiscal year-to-date tax collections and sewer use collections. Following the review, on a motion made and seconded by Klimkoski/Achilli, it was unanimously VOTED TO:

Following the discussion, on a motion made and seconded by Achilli/Kirschner, it was unanimously VOTED TO:

#### **BVFD**

Mrs. Parente presented information on bids received to replace the main firehouse's roof. On a motion made and seconded by Klimkoski/Achilli, it was unanimously VOTED TO:

Authorize up to \$75,000 from BVFD Reserve for new firehouse roof.

### Financial Report

Mrs. Parente presented and reviewed with the Board key financial reports through December 6, 2017. The Board also reviewed non-budget account revenue and expenses, along with bank/investment/reserve account balances. She also reported on the police considering a new vehicle; dial-a-ride needing a better all-weather vehicle; and, State OPM restoring funding for reimbursements to resident renters but offsetting this increase with a further reduction to the Town's ECS funds.

Following her report, on a motion made and seconded by Klimkoski/Achilli, it was unanimously VOTED TO:

Accept December 6, 2017 Financial Report as presented.

**First Selectman's Report**: Mr. Shafer reported that the Library expansion project received its certificate of occupancy and it should be completed on time and within budget.
