- 9. **Taine Mountain Parcel**: Kate Brown, attorney for the Trust for Public Land reported on State's economic situation and status of the trust's application for DEEP's Open Space and Watershed Land Acquisition Grant.

A motion was made, seconded and passed unanimously by Mark DiOrio and Gerald Mullen in favor of purchasing the Taine Mountain parcel for \$800,000 where the purchase will be contingent on the

receipt of a \$520,000 CT DEEP Open Space and Watershed Land Acquisition Grant and \$50,000 from the Burlington Land Trust; the Town's share of the purchase not to exceed \$250,000 from the Town's unassigned revenue per the Town Charter to move the question to the Agenda at the Town Budget Meeting on June 2, 2015.

10. Budget Workshop: The Board reviewed and discussed the 2015-16 Town Budget.

Chairman DeNicola asked if there was any further business to come before the board. There being no further business, a motion was made, seconded and passed unanimously to adjourn the meeting at 10:46 PM by Gerald Mullen and Mark DiOrio.
