Application 2020-009-Larson-Driveway-Johnson Court #9-Application to construct a new driveway for new home construction after demolition of new home.
Application 2020-010-Hemmingway-Above ground pool w/ deck & shed relocation- Covey Road #204-Application to install above ground pool with wood deck and relocate existing shed 6' to accommodate pool within the Upland Review Area.
Application 2020-011-Ruzzi- Fill-Stafford Road #154- Application to bring in approximately 600 cubic yards of fill and remove very small/stumps to level off and taper back yard to start at the same topography as the leech fields, entirely within the Upland Review Area.

Application 2020-013-Gannon-Shed-Mountain Top Pass #29-Application to place a pre-fab 10 X24 shed on gravel pad within the Upland Review Area.
