## **Financial Report:**

Director Twomey gave budget update. Camp salaries, programs and MyRec financials were discussed. Future capital expense items for consideration were discussed.

## **Facility Opening and Procedures:**

Fields will be open April 15. New nets on Tennis courts ordered. Seams on tennis court surface need a reglue.

Lifeguards are needed for summer camp.

Director Twomey is preparing upcoming COVID facility protocols. (ref. guidelines from State and BBHD) for face masks and social distancing:

Protocols were the same as fall with a few adjustments with exemptions in quarantine for individuals that are fully vaccinated or had covid with 90 days and changes in mask protocols as follows:

Mask wearing and quarantine protocols were discussed:

- Full time mask wearing recommended at all facilities, but not required during active play.
- Fans Have to be masked at all times. Number of fans allowed is being set at 200 people.
   There will be fence signs declaring fans must wear masks at all times.
- Quarantines State guidelines for sports will remain at 14 days

Parks and Recreation Commission members were in agreement with reopeining guidelines for spring 2021.
