

## BURLINGTON WATER POLLUTION CONTROL AUTHORITY MINUTES OF REGULAR MEETING October 18, 2017

- 1. <u>Call to Order</u> The meeting was called to order at 7:00 PM. Commissioners present were: Chairman Bill Parente, Jim Grappone, Eric Eggleston, Charles Lanfair, Paul Bystrak and John Jozwik. Also present, First Selectman Ted Shafer and Beverly Jackson, Clerk.
- **2.** <u>Farmington Plant Upgrade, Original 1981 Agreement</u> **Motion** made (Lanfair), seconded (Bystrak) and approved unanimously to move agenda item #7 to item #2.
  - -First Selectman Shafer spoke with Brandon Robertson from Avon and Robert Skinner from Canton regarding WPCA and the Farmington upgrade. The Town of Avon has hired Joseph B. Schwartz, Murtha Cullina from Hartford who handles WPCA matters.
  - **MOTION** made, seconded and passed unanimously to pursue hiring Attorney Schwartz to represent the Town of Burlington WPCA concerning Farmington plant upgrades contingent on securing funding from the Board of Finance. (Bystrak/Grappone)
