

BURLINGTON WATER POLLUTION CONTROL AUTHORITY SPECIAL MEETING MINUTES Thursday, May 21, 2020 Via Teleconference

- 1. Call to Order The meeting was called to order at 7:06 PM. Commissioners present were: Chairman Bill Parente, Paul Bystrak, Eric Eggleston, Charles Lanfair, Steven Perry and Jim Grappone. Guests: First Selectman Ted Shafer, Matthew Jermine, Fuss & ONeill, Atty Al Smith, Murtha Cullina

- 2. Act on the Minutes from April 16, 2020 Motion made, seconded and passed unanimously to approve Special Meeting Minutes of April 16, 2020. (Grappone/Lanfair)
- 3. Correspondance:
 - a. Invoice dated May 12, 2020 from Murtha Cullina.

Motion made, seconded and approved unanimously to approve payment of the invoice from Murtha Cullina dated May 12, 2020 in the amount of \$ 2650.00. (Grappone/Eggleston)

4. Farmington Treatment Plant Update:

Attorney Al Smith updated the Commission stating that there has been no additional correspondence or response from Farmington since March.

Matt Jermine stated that Farmington installed (within Burlington's boundary) a flow meter at the intersection of East Shore Blvd and southwestern entrance to Circle Drive. Atty Smith will request flow results from Farmington.

Jermine reported on sediment in the sewer main along East Shore Drive between the two Circle Drive intersections. Recommends the line get jetted because throwing off the sensor level. Will contact Scott Tharau, DPW.

5. **Public Hearing**: To Consider, Accept and Approve the Sewer Use Fees for the Year 2020 for Bristol, Canton and Farmington Users.

Motion made, seconded and approved unanimously to close the regular meeting and open the public hearing at 7:32PM. (Grappone/Bystrak)

Cheryl Byrne-26 Strong Street- recommended that WPCA have additional meters installed to get accurate flow data.
