 ZBA application 2023-565 – Teddick – Side Yard Setback Variance – Alto Rd #25.

Motion made, seconded, and passed unanimously to suspend the regular meeting and open the Public Hearing for **application 2023-565 – Teddick – Side Yard Setback Variance – Alto Rd #25**. Farmer/Dubois at 7:11PM.

Applicant Bryan Teddick was present and presented information to the ZBA regarding his request for the Side Yard Setback Variance.

Written Communication was received from Spencer Greene of 19 Alto Road in support of application 2023-56.

Jerry Burns was present and spoke in favor of this application.

Motion made, seconded, and passed unanimously to adjourn the public hearing and reopen the regular meeting at 7:34PM Dubois/Bernetich

Motion to approve Application 2023-565 - Teddick - Side Yard Setback Variance - Alto Rd #25 for a 14' variance to the 25' required side yard setback to 11' side yard setback for a 16' x 16' carport for residence built in 1951 with the following restriction:

1) The carport cannot become living space.

Hardships:

- 1) The parcel was created prior to the 1958 adoption of Zoning Regulations in Burlington.
- 2) The home was built in 1951 prior to the 1958 adoption of Zoning Regulations in Burlington.
- 3) The lot width is 50' less than today's R-44 Residential Zone requirement due to pre-dating the 1958 adoption of zoning regulations.
- 4) Had a garage or carport been part of the new dwelling project in 1951, it would have been grandfathered as shared earlier.
- 5) The carport cannot be located to the rear to meet today's 25' setback due to the topography that exists right behind the home. Cargill/Farmer



Motion made, seconded, and passed unanimously to amend the motion to include the restriction that *the carport cannot become living space*. Perkins/Farmer
